# Work Process

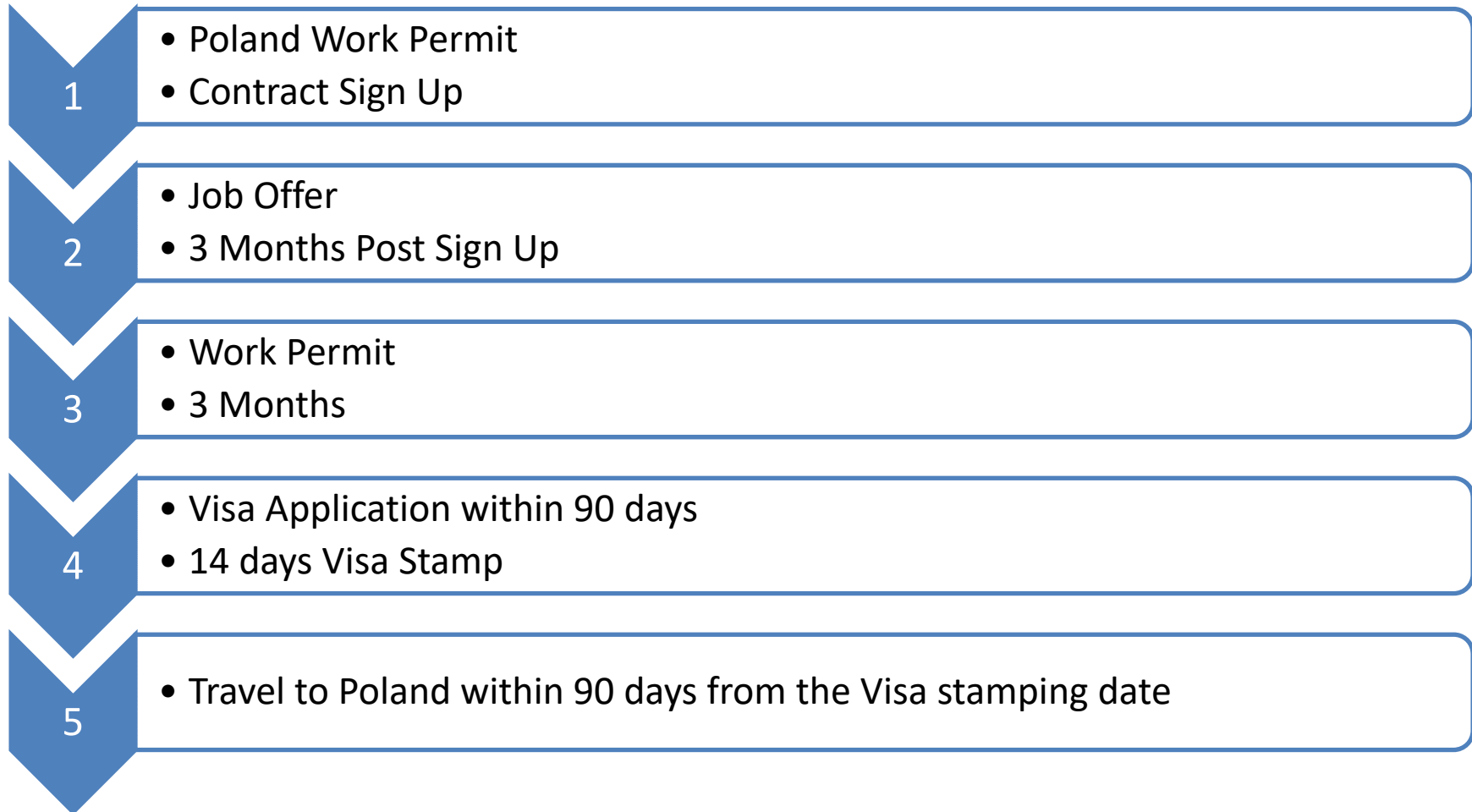
- Global Gateways contract will be sent to the client for review.

# Work Process

- Post receiving this letter, the client will take the appointment in the embassy to apply for the work Visa and update us the date for interview in the embassy.
- Our lawyers will also provide us with the cover letter, and also convey the intentions of hiring you for the job.
- If the visa is Refused, Client must give us a letter with an official refusal so that we could write another letter of appeal.
- Once the visa is approved, client will clear the balance amount of payment with Vertex Migrations
